COUNTY OF SUSSEX BOROUGH OF BRANCHVILLE ORDINANCE # 06-2024 AN ORDINANCE TO SUPPLEMENTAL CHAPTER 123 ZONING: ARTICLE VI. SUPPLEMENTAL REGULATIONS.

WHEREAS, it being determined by the Mayor and Town Council and the Planning and Zoning Boards of the Borough of Branchville that Chapter 123. Zoning. Article VI. Supplemental Regulations. should be supplemented to include a provision authorizing temporary signage to be installed the fencing surrounding the baseball/softball field located at Block 201 Lot 21; and, WHEREAS, the Mayor and Town Council of the Borough of Branchville deem it to be in the best interest of the residents of the Borough to modify Chapter 123. Zoning. Article VI. Supplemental Regulations include as be supplemented to add new section §123-19.1 as follows; and,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Town Council of the Borough of Branchville, County of Sussex and State of New Jersey as follows: Chapter 123. Zoning. Article VI. 19.1. Placement of temporary signage on the interior of fencing surrounding the baseball/softball field located at Block 202 Lot 21 shall be permitted subject to the following:

A. Prior to the placement of signage, a permit shall be obtained from the Branchville Borough Clerk. The cost of the permit shall be \$200 per sign per year. A template of the proposed signage shall be provided in the application. The Mayor and Council shall be authorized to reject an application for signage that proposes installation of a sign deemed to contain obscene content or material as defined in N.J.S.A. 2C:34- 2 and N.J.S.A. 2C:34-3.

B. Signage shall face the interior of the baseball/softball field and each sign shall have
a dimension of not greater than four (4) feet in height and six (6) feet in width.
C. Signage shall be authorized to be placed on the fencing between April 1st and
November 1st . After November 1st, the Applicant shall remove the signage.

Failure to remove the signage shall be deemed to authorize the Borough of Branchville to remove the signage, D. New permits shall be required for each calendar year. Savings Clause. The remaining sections of Chapter 123 shall remain in full effect. Inconsistency. All ordinances or parts of ordinances or resolutions that are in conflict with the provisions of this Ordinance are repealed to the extent necessary. Partial Invalidity. If any article, section, subsection, term or condition of this Ordinance is declared invalid or illegal for any reason, the balance of the Ordinance shall be deemed severable and shall remain in full force and effect.
